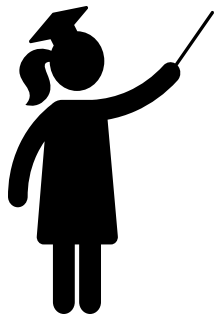
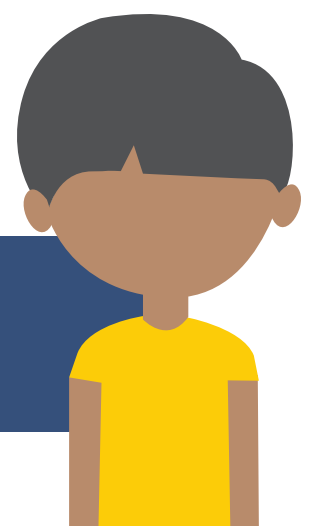

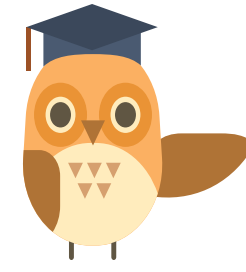

# - Greeting from PEB Executive Director -

*"In everything you do, put God first and He will direct you and crown your efforts with success."*

This was my father's advice to me when I joined PEB in February 1998. Secondly, drawing on his work as an accountant, he told me not to touch money and to maintain a strictly supervisory role. I began my mission work with fearless commitment, coupled with great strength derived from my trust and faith in God. My passion was to educate young girls – same as my mother Mohanda Bibi who was a young scholarship student educated at Sangla Hill boarding house. Education had positively impacted our family and my life, and my mother encouraged me to make a 2-year commitment to the mission of PEB – a way to “pay it forward” to benefit other deserving girls. I never imagined that I would still be serving PEB 20 years later.

The journey has not been without challenges and difficulties. Along the way, there have been threats, hardships, roadblocks, and much opposition. But it has been a rewarding and miraculous journey as well. I will share some of the awesome moments over the past 20 years:

- In 1998 PEB took responsibility for 7 denationalized schools. Today there are 24 schools.
- At one time the schools had no restrooms; now there are 19 new buildings.
- In 2004 only 12 students from Martinpur Girls' School graduated in science. Now many PEB students are enjoying successful careers as doctors, engineers, nurses, and lawyers.
- The student population has grown from a few hundred students to nearly 6000.
- The staff increased from 40 PEB employees in 1998 to 600 employees today.
- Local resources have increased from 5% to 60%.
- There has been an exponential increase in fundraising, from \$2000 annually to \$1.2M.
- Two US 501(c)(3) organizations with independent boards support PEB and SHE.

I am grateful to the Friends of PEB organization that has been God's hands here on earth. Their guidance and support have been vital in PEB's advancement to ever higher levels over the years and a source of strength for the PEB family.

## **A Personal Note:**

Dear friends, 2018 has been the most difficult year in my personal life. As we celebrate 20 years of PEB's achievements, I am grieving the loss of my husband Javaid, my marital partner of 37 years and an unwavering supporter of PEB. During his hospitalization, I was able to see the fruit of PEB's hard work in the faces of 4 nurses and other medical personnel who were graduates of Martinpur and Sangla Hill schools. This was a blessing to me in the midst of my most trying days.

PEB is committed to following zealously in the footsteps of the early missionaries. Our aim is to provide more and more scholarships for needy children who are among the millions of Pakistani children not enrolled in school. We are developing strategies to sustain our system for the next 100 years. And we envision opening more schools as opportunity allows. Please join hands with us in educating many more Mohanda Bibis for a better Pakistan and a better world. Thank you for your partnership.

## The FOPEB Family is Growing!

After each of our three children was born, my husband and I “adopted” a child through an international sponsorship program. Our kids grew up looking at photos on the refrigerator of their “siblings” and praying for them at night. At birthday parties we would pull out the world globe and tell their friends about our sponsored children’s lives.

I truly believe that our monthly donations for the 20+ years allowed our sponsored children to grow in ways they could never have otherwise. They all broke the cycle of illiteracy in their families - that is something to celebrate! Our children’s lives were also enriched. They developed compassion as our nightly prayers took them to other parts of the world, prompting them to give thanks for their own comforts and opportunities. This intentional global focus also helped our whole family to grow in faith when we were called to move to Pakistan for 5 years.

Now our kids have grown up, as have our original scholarship students. We recently added 3 PEB students to our “family.” I had the privilege of meeting two of them on a visit to Pakistan.

Thanks to generous church groups and individuals, funds for 520 student scholarships were received in 2017. Still, there are many more children needing scholarships.

Well, I'm pleased to say the Board of Friends of PEB is far wiser and more careful than were my wife and I. As FOPEB trekked through 2017, we have devoted considerable time, energy, and expertise to making certain PEB has what it needs to climb higher and higher into its future and is enabled to serve an increasing number of students, families, and communities. Among the Board's actions in 2017 were:

- upgrading our expressions of appreciation to donors and strengthening relationships with donors, building new relationships with potential donors while focusing specifically on increasing scholarships;
- celebrating the completion of funding for the Sargodha Boys' School 1B (\$320,000);
- undertaking major fundraising for Pasrur Boys' School (\$121,000 of \$200,000 raised), Sargodha Girls' Boarding House Phase II (\$52,000 of \$115,000 raised); and Martinpur Boys' School (\$250,000 of \$480,000 raised);
- celebrating the years of devoted service to FOPEB by staff member Lynn Miller;
- celebrating the occupation of Phase I of the PEB office building and completion of the "Fill the Office Campaign;" and
- making plans for the celebration of PEB's 20th anniversary in 2018.

Of course, we are enabled to do all the above (and more) thanks to the generosity of the numerous individuals and congregations who join in the faithful ministry that is FOPEB.

## Scholarships Are a Blessing

A casual conversation with Veda Gill in Lahore, Pakistan in January 2011 was my introduction to the desperate need for scholarships for PEB students. After learning that her driver's children needed financial support to be able to remain in school, my family chose to respond to the need and provide a way for these two kindergartners to continue the academic journey that they had just started. It was a no-brainer for us: God calls us to share our blessings with others and here was an opportunity for us to fulfill that call. Now, 7 years later, the girls are still in school despite bumps, twists, and turns along the way. I saw Esbah and Jessica on my second trip to Pakistan in November 2015 – and I can truly say that seeing them thrive at school lets us know that sponsoring them was the right decision.



My involvement with PEB dates back to 2009 when I began serving as administrative assistant for the newly-formed Friends of PEB non-profit organization. In 2015, as I approached retirement, I took responsibility for the scholarship program only – a function I performed for two years. Since January 2018 the scholarship program has been administered by Judy Ortolano.

Over the years I watched gratefully as more and more donors chose to answer the same scholarship call that my family did. What is truly gratifying is that so many donors make a long-term commitment, generously renewing their scholarships annually. As I have traveled to various congregations and shared the PEB story, I have been greeted by some of these donors who express their joy and appreciation at being able to share their blessings with the PEB family. It is very heartwarming to talk with people who recognize the value of a scholarship in offering hope to a child and, by extension, to the child's family. Let's continue to support young people in a distant part of our world as they pursue their academic aspirations.

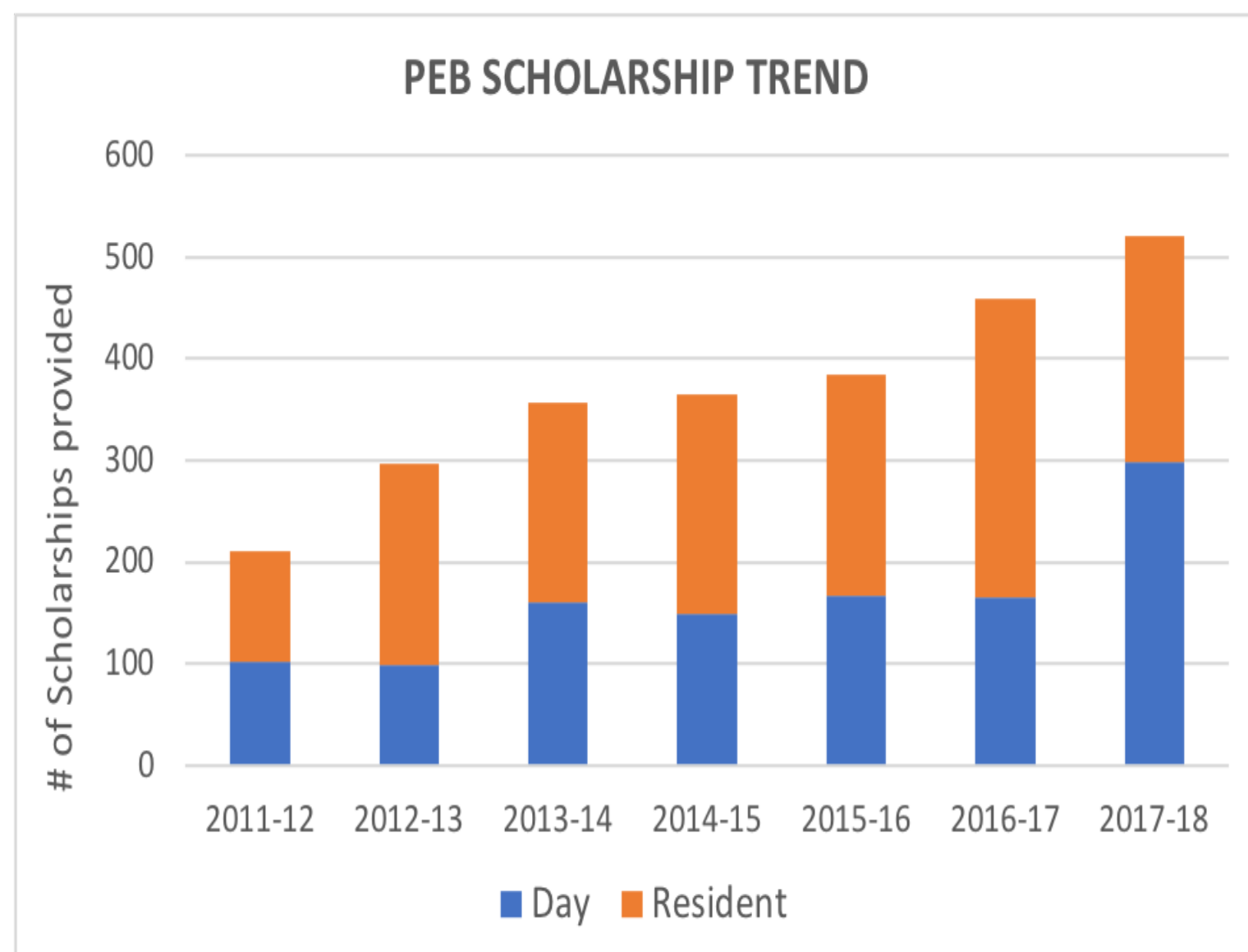


## - About PEB Scholarship Program -

Scholarship students have been identified by PEB as deserving and capable students who will greatly benefit from financial support to supplement the small parental contribution to school fees. Upon their initial contribution, U.S. donors receive a profile of a scholarship student. A thank you note with updated photo of the student is sent to the donor each fall.

Exploration Trip visitors to Pakistan may have the opportunity to meet scholarship students. However, in the best interest of the student and donor, personal relationships with students are discouraged.

### Scholarships Change Lives



**Kashish** is a 1st grade student at CGHS Sargodha. She is a bright student with excellent grades. She has two brothers and five sisters. Her father has kidney failure and is unable to work. Her mother struggles with diabetes but still works in a few homes as a maid to provide basic needs for her family. For the past two years, none of the children were going to school. Kashish's mother visited CGHS Sargodha and learned that scholarships were available for deserving families. All four daughters were admitted. With the helping hand of PEB, Kashish is able to gain an excellent education. She has the potential to compete with other students and perform well. Kashish's mother wants her four daughters to complete their education and be independent adults. Kashish and her family are very thankful for the generosity and support of PEB.

**Sheeza** is a 5th grade student at CGHS Sangla Hill. She is from an outlying village. When her father died of a heart attack, she had to drop out of school to help her mother sell stationery door-to-door. Although her mother really wanted to educate her daughter, this sales job did not pay enough to allow Sheeza to return to school.

A person from their village told them about PEB's school in Sangla Hill. Sheeza's mother applied for a scholarship. After the school scholarship team evaluated their situation, a scholarship was granted so Sheeza could continue her education. Sheeza burned the midnight oil to prove her ability and has been achieving excellent grades. Sheeza and her mother are grateful for the support of PEB.





# - PEB Inter-School Competitions -

## **Science Fair (Started in 2008):**

Students put on their thinking caps and address real-life problems that impact Pakistan and the world. 2017's competition included investigative projects, a science quiz, and a problem-solving challenge in which students were asked to design a hand-washing system that would help stop the spread of bacteria.



## **Urdu Debates (Started in 2005):**

All PEB high schools compete in the annual Inter-School Urdu Debates. Students must clearly debate the topic while they are judged on how well they express and defend their ideas. The 2017 topic was "TV plays a positive role in building the society."



## **English Debates (Started in 2014):**

PEB high schools compete in the annual Inter-School English Debates. Students must clearly discuss their platform on the chosen topics. They are judged on content, style, and strategy, all while translating from their native Urdu to English. In 2017 students spoke for or against the topic "Democracy is the best form of government."



## **Sports Competitions (Started in 2014):**

Students gather to celebrate physical fitness by competing for their school in a variety of activities ranging from tug-of-war to hurdles to relay races. They work as a team while learning respect, patience, determination and team-building skills. This event is a student favorite!



## **Christmas Carolling Competition (Started in 2007):**

Each December, students from the PEB schools gather to sing prepared Christmas songs. There are individual and group competitions. This activity is highly anticipated by the students and is a joyous start to the Christmas season.

## Building Hope



### **Christian Girls' Higher Secondary School, Sangla Hill:**

On November 13, 2017, PEB Executive Director Veda Gill, along with US visitors, including Dr. Tom Davis from Hershey, Pennsylvania and Rev. Diane Jamison of Abington, Pennsylvania attended the dedication ceremony for the new higher education block. This 2-story building provides classrooms and laboratories where girls can continue their education beyond 10th grade with a concentration in science or liberal arts.

### **Sargodha Boys' English Medium School:**

The second phase was dedicated on November 15, 2017. Nancy Ege and Molly Hundley (daughters of the late Howard Davis Ege) attended this special event in tribute to their father, whose generosity during his life and in his memorial contribution made the construction of Sargodha Boys' School a reality. The project includes classrooms, staff room, and bathrooms. The building will accommodate 2000 students when all 9 phases are completed.



### **PEB Office Building:**

Dedicated on November 19, 2017, the long-awaited first phase of the office building is complete. Staff began moving into their offices that week and rejoiced in their safe, spacious and beautiful new facilities. The first-floor houses administrative offices, a boardroom, reception area, kitchen, IT support, and bathrooms. A special thank you to all the generous donors that made this dream come true!

A second floor will be added with teacher training facilities and guest rooms when funds become available.

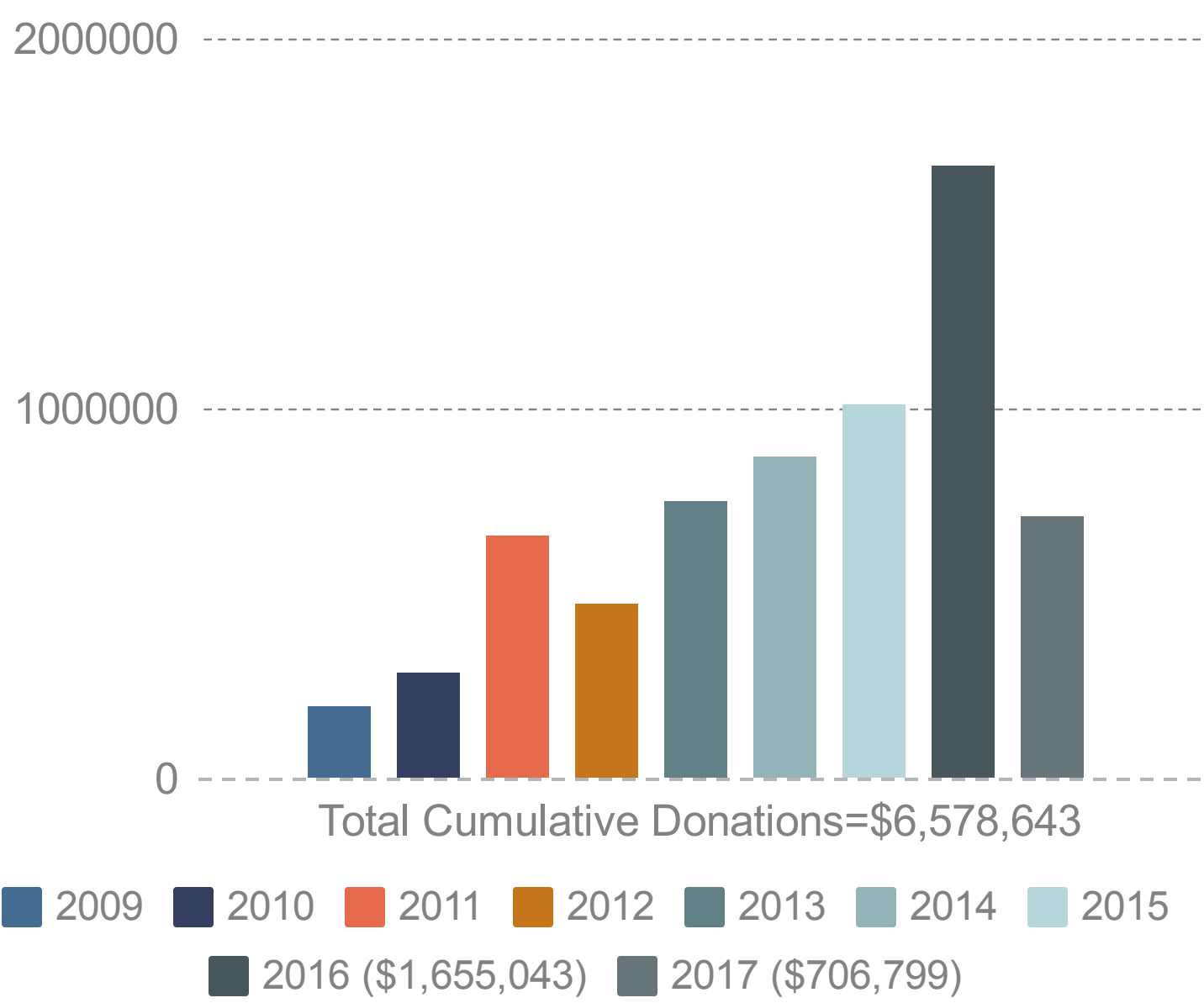

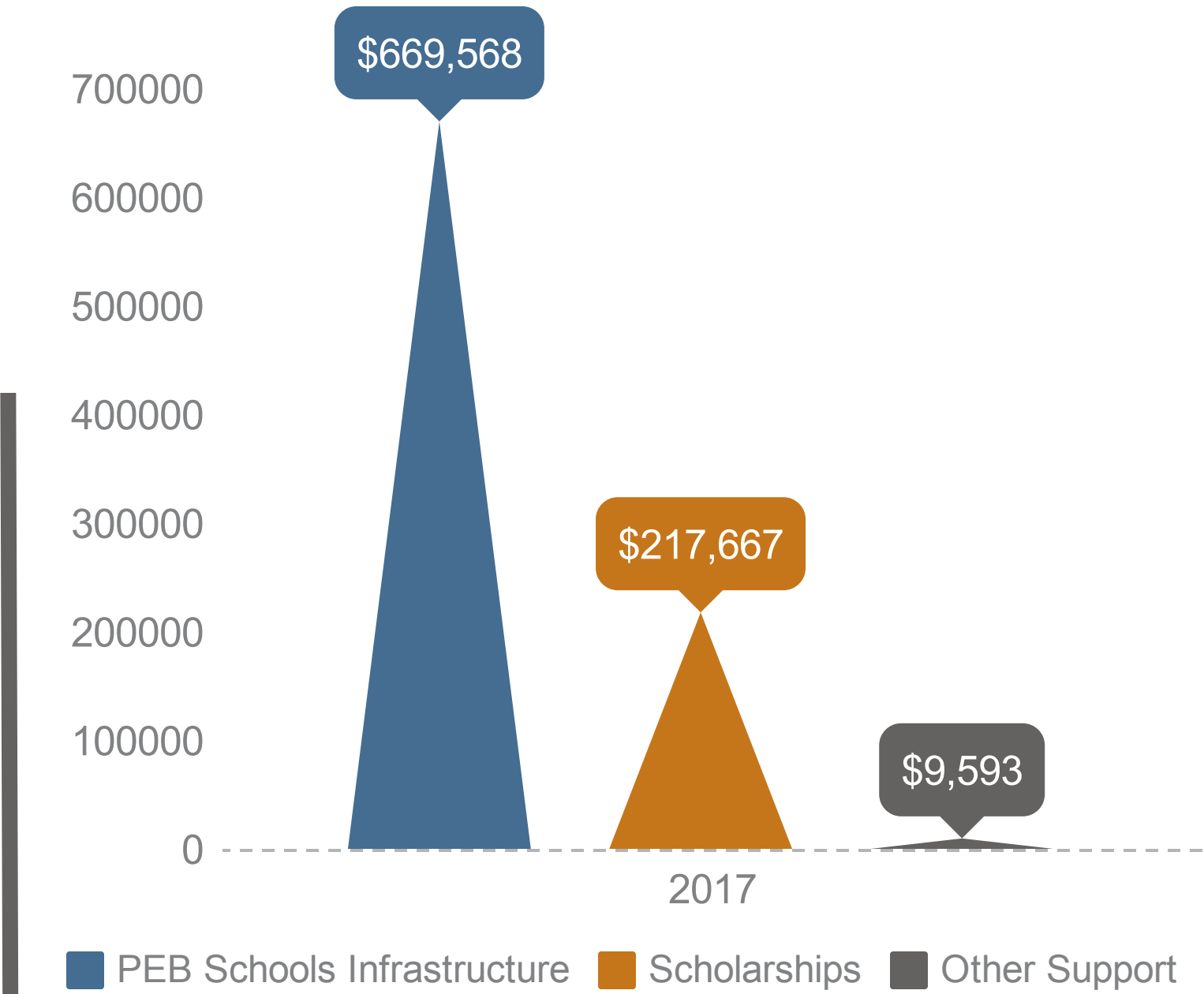

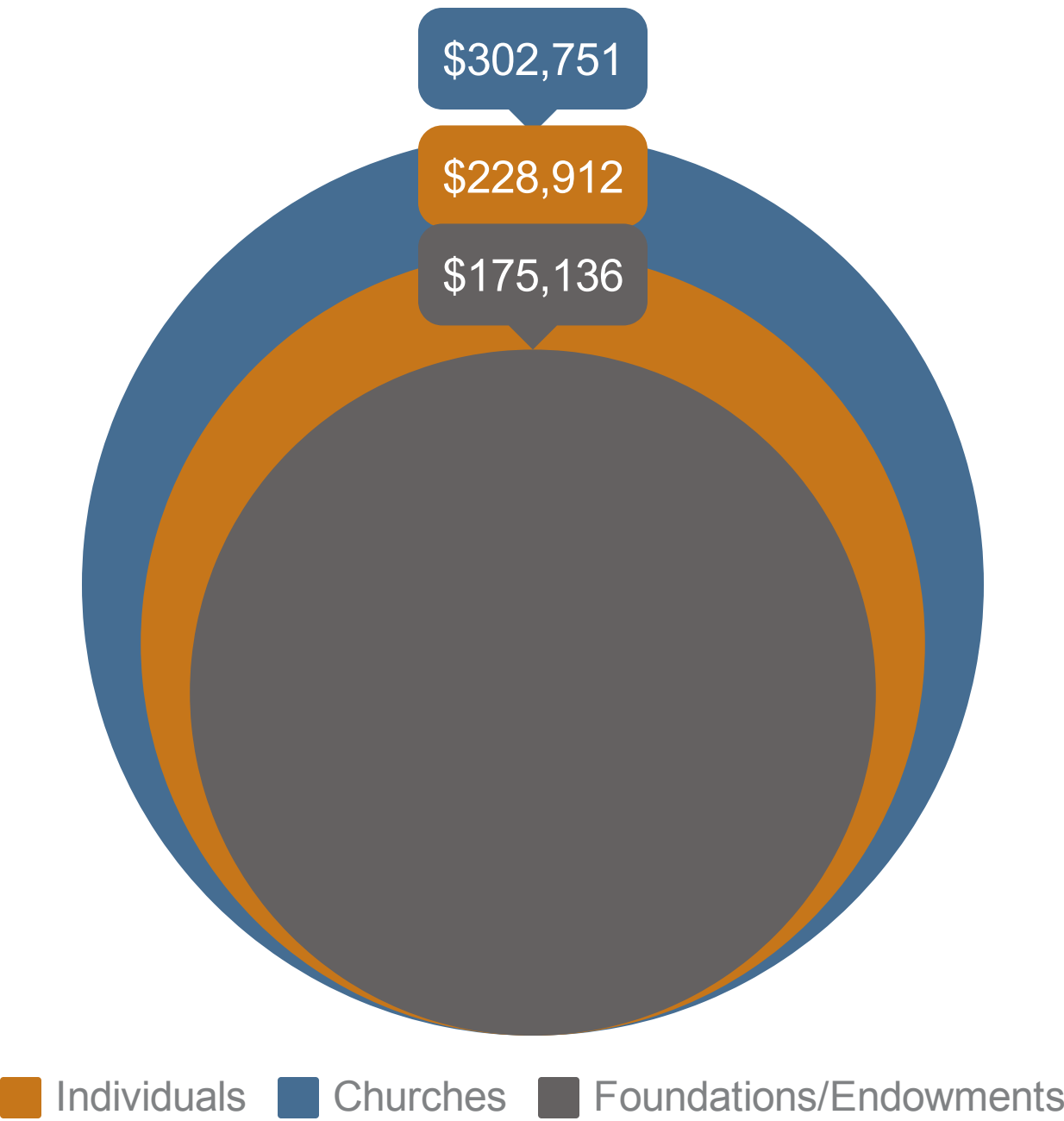
### Donations to FOPEB



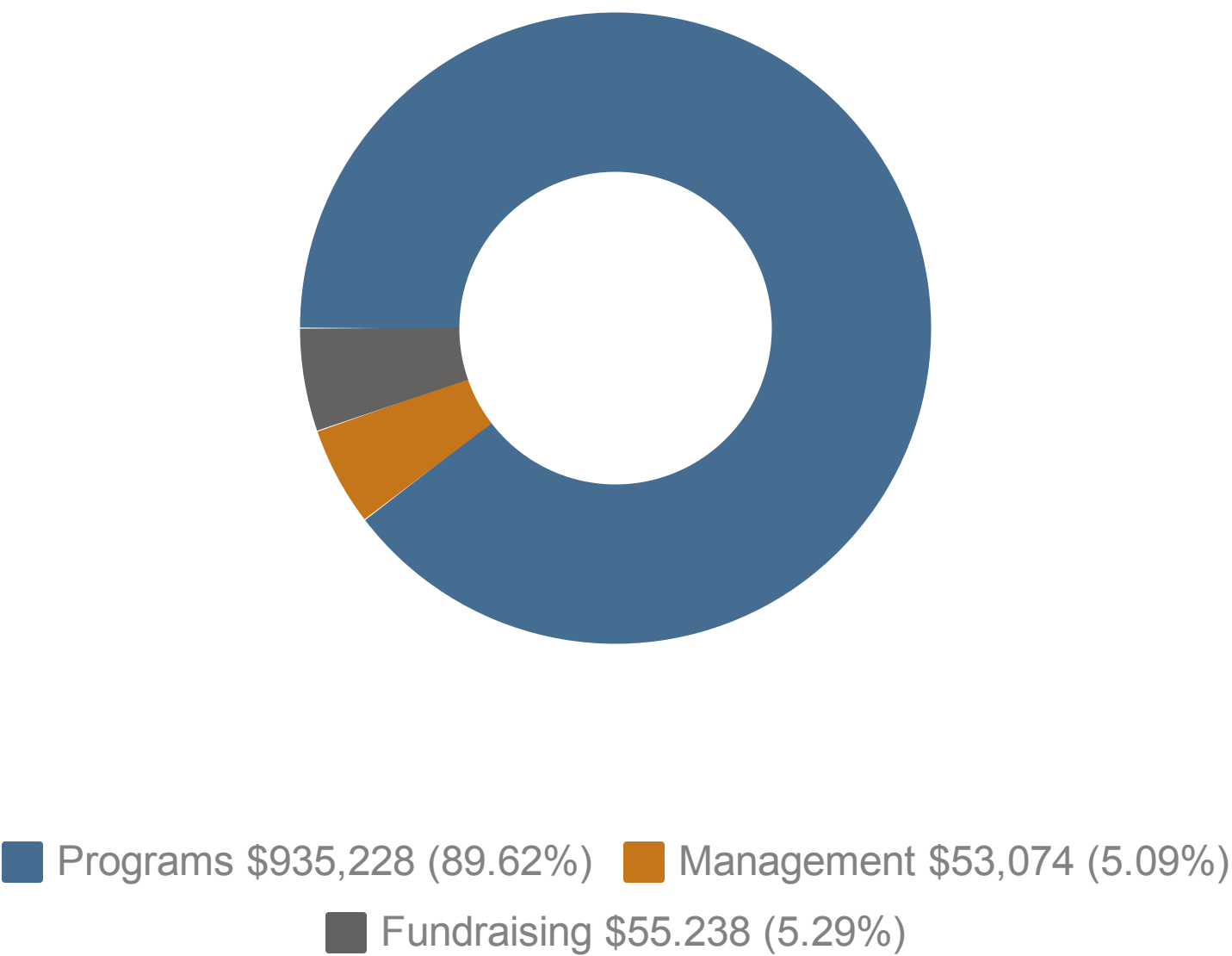
### Grants to PEB



### Revenue by Source \$706,799



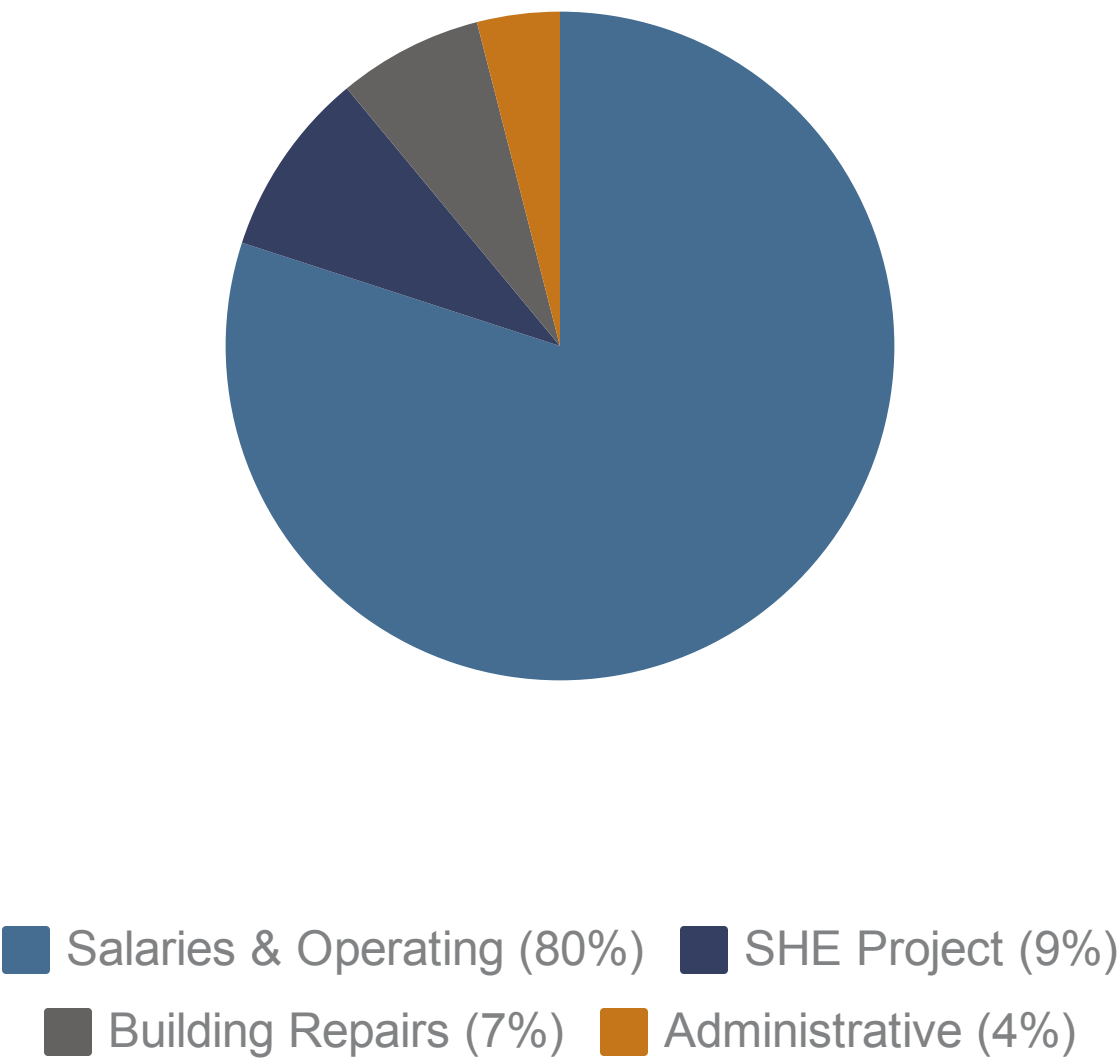

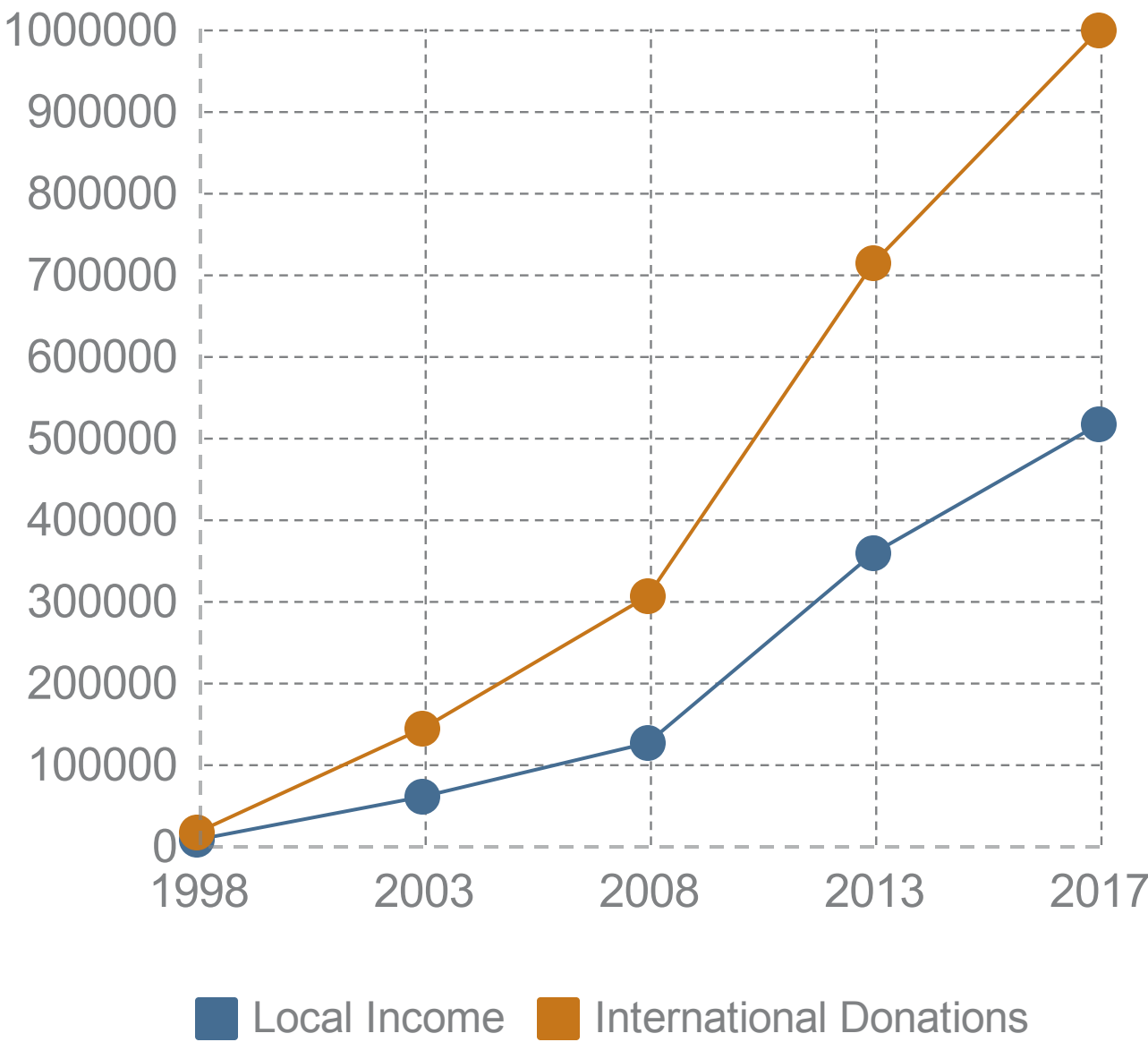

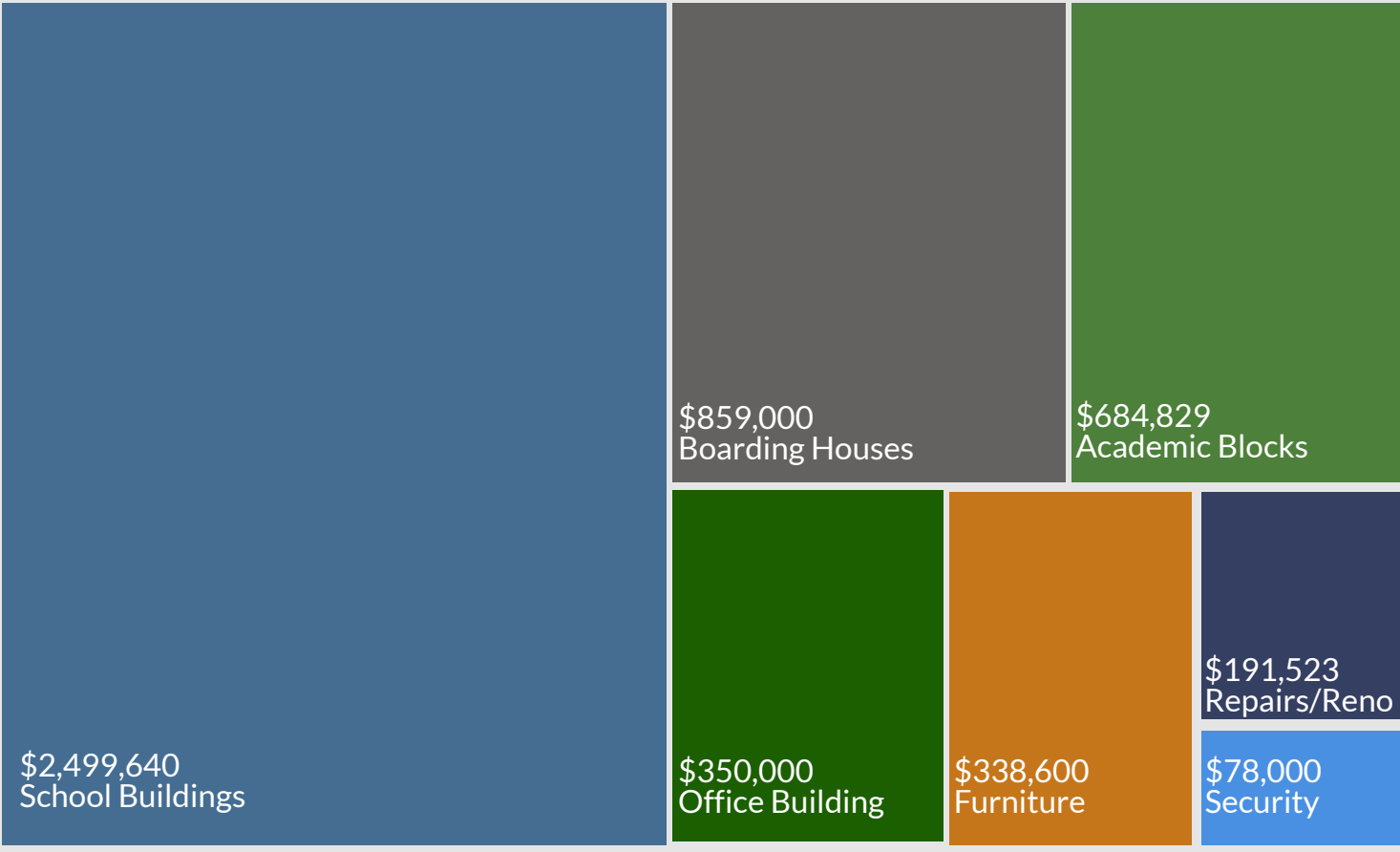
2017 Expenditures

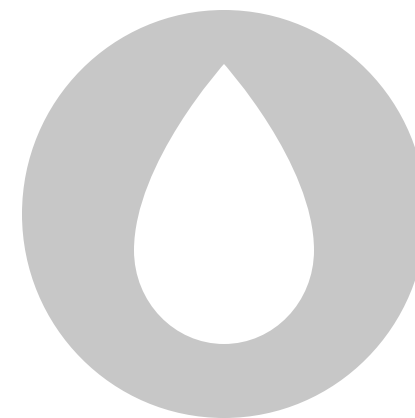

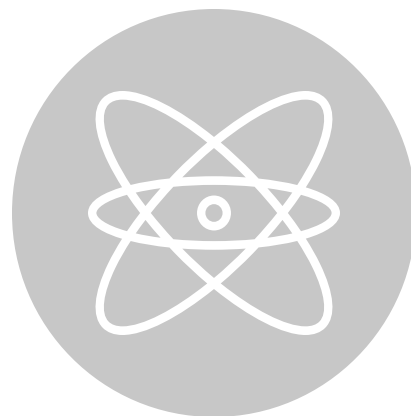
